GUIDELINES FOR THE SEARCH FOR UP MANILA OUTSTANDING ARTIST 2017

Eligibility:

1. An employee or a student of the University who has published / exhibited /performed works of art* for the year 2016-2017.
2. Nominee should have at least satisfactory performance / with good academic standing, whichever is applicable during the year in review
3. He / she must be nominated by an individual or by an organization within the University
4. The Dean / Unit Head / Director must duly endorse the nomination.

Criteria for Selection

1. Creativity of the artist in handling of his / her subject and the resources of his / her medium, "creativity here is understood to mean inventiveness endowing the given material and medium of the artist with freshness and original insight
2. "Impact" is a manifest effect of stimulating a fresh outlook / thought / perspective on the material and the medium of the artist among his / her audience. Impact includes contribution to UP Manila, promotion of arts and willingness to share among UP Manila constituents and to outside communities

Documents to be Submitted Together with the Nomination Form:

1. Copy (-ies) of the published work(s), or an audio/video recording of the performance(s) (in MP3/MP4 file format, saved in a USB drive), photo-documentation of the work(s) in the visual arts. Please include brief description of the artwork (subject and medium).
2. Brief resume of the nominee highlighting activities as an artist
3. Published reviews / critiques of the specific work (s) for which the artist is being nominated. Where published reviews or critiques are not available, the nominating party may present instead evaluation of the work(s) by an individual recognized as an authority in the field and duly signed.
4. Proof of at least satisfactory performance / good academic standing.

* Art forms may include, but are not limited to, visual (painting, photography, graphic design, pottery, sculpture, woodworks, etc.); performing arts (film / theater, music / dance, etc.), literary (poetry, creative writing), fashion, culinary arts, flower arrangement, etc.
